### **Authorization to receive official communications**

### **Notice for Clearance of Goods**

If there are no grounds for exemption under Article 181c of the Implementing Provisions of the Customs Code (e.g. goods carried in personal luggage of passengers), a summary entry declaration of goods carried must be made.
